It is Rendering Period in the Luna County Assessor's Office.

#### **DEADLINE DATES FOR RENDERING:**

- January 1, 2022 February 28, 2021
  - o Livestock / Personal Property / Grazing Leases & Manufactured Home Stickers
  - There will be a 5% penalty assessed if these are not completed by the end of February 2021
- January 1, 2021 April 30, 2021
  - Head of Household/Family Exemptions, Veterans Exemptions, Other Government & Non-Government Exemptions, 65 & Older/Disabled Limitation Freeze (\* \$35,000.00 total Household Income to Qualify)
- We are encouraging the public to use our online services. We have put all necessary documents online available to you, if you do not have access to a computer please call us and we will mail necessary documents to you.
- You can sign up for your exemptions online but those signing up for veterans exemptions can
  either mail in your veterans certificates or call the office to schedule an appointment; we will
  need to sign off on those certificates
- Anyone interested in filing for 65 & older or disabled limitations will also need to call in to schedule an appointment or mail in your application with all required documents. The Limitation Freeze required income *to qualify is \$35,000.00 total income to the home*.
